#### A. Q&A for the 12:00 p.m., September 15, 2022, Public Meeting

Q: *Town of Prospect Mayor*: When this phase of construction is over, will overweight/overlength vehicles be allowed onto Interstate 84?

A: A steel strengthening program and load rating study was recently completed as part of the Rehabilitation Project. So, overweight vehicles are allowed on I-84 now and will continue to be in the future.

Q: Town of Prospect Mayor: Do you anticipate any problems with traffic in Prospect during the future construction of the New Mix? I am concerned about traffic being detoured onto Route 68 and through the Town of Prospect. This occurred in the past when I-84 was rebuilt on the east end of Waterbury.



A: That is a big challenge. As we look to potentially replace the Mixmaster we are going to do so in a way to carry traffic on the highway or structures purposely built to avoid large detours through local communities.

Q: Kevin Ellis (Naugatuck Valley Council of Governments (NVCOG): The State put out a directive targeting a Vehicles Miles Traveled (VMT) reduction over the next decade. However, this project shows an increase with VMT. Is there a consideration to align your VMT projections with the goals the State of Connecticut has?

A: The governor did issue an executive order and the Department of Transportation is currently working on developing a plan to achieve a reduction of VMT. We will incorporate any changes that may be needed in this project in accordance with that plan.

Q: *Jackson Hurst:* If CTDOT decides to go with the tunnel alternative and there is an increase in cost compared to other alternatives, is there a possibility of using tolls to offset the project cost?

A: Currently, that [tolls] is not being considered but is something that could be looked at in the future. The tunnel option may not be underground, the way we typically think of tunnels. If used, a tunnel option could be a depressed section of the highway that is built over providing developable or available land.

During a pause in questions, CTDOT noted that the New Mix project team is getting the word out about the New Mix project by attending community events, regularly meeting with the Project Advisory Committee (PAC) that includes representatives from City Hall, the hospitals, neighborhoods and others.

Q: *Kevin Ellis (NVCOG)*: A focus on this interchange is to move traffic along Interstate 84 and Route 8 and may have negative impacts to Waterbury and other neighboring communities, such as environmental justice. What steps would you take to mitigate or eliminate any negative impacts to the city?

A: Construction of highways back in the 1960s did divide communities across the country, including Waterbury. Urban planning is a part of the New Mix PEL study. As we narrow down alternatives in Level 2 and Level 3 screenings, we will be incorporating some of these urban design strategies to reconnect the community and improve traffic not just for motor vehicles but also for public transit such as busses and trains. With the train station in Waterbury as well as bus service, there are a lot of opportunities to get into the urban planning side of things. Urban planning and design professionals have been involved from the beginning, not as an afterthought.

At this point in the meeting, there were no further questions or comments from meeting participants. Q: *Karen:* I want to make sure I understand correctly—right now you are going through the process to narrow down the options. The feedback that you are looking for now is that relative to the process you are following, or do you want feedback on some of the alternatives?

A: We would love to hear public feedback about the process, the alternatives, and the screening criteria, and anything we discussed during this meeting.

Q: *Thomas*: Thanks for the presentation. Is there a high-level preference for a partial interchange or a complete interchange at this level? I personally would be in favor of complete interchange.

A: We cannot give you a preference as the alternatives are all going to go through the funnel that was shown earlier in presentation. There are some movements on the interchange that do not carry as high of a level of traffic as others. We are juggling a lot of factors. The ideal outcome would be to have a complete system interchange with the highway connections, but this is a very constrained area so there may have to be some adjustments and accommodations that are made.
